### LEYZA F. BLANCO'S, FORMER RECEIVER, FIRST AND FINAL APPLICATION FOR REIMBURSEMENT OF LEGAL FEES AND EXPENSES AND MEMORANDUM OF LAW IN SUPPORT OF SAME

Leyza F. Blanco ("Blanco"), Former Receiver, pursuant to this Court's Order Appointing Receiver dated April 20, 2009 (hereinafter, "Order Appointing Receiver") moves this Court for an Order Approving the Reimbursement of Legal Fees and Expenses ("Motion"). The grounds for this Motion are fully set forth in the Memorandum of Law below.

#### I. GENERAL BACKGROUND

On April 20, 2009, this Court entered an Order Appointing Receiver over FOUNDING PARTNERS STABLE-VALUE FUND, L.P., FOUNDING PARTNERS STABLE-VALUE FUND II, L.P., FOUNDING PARTNERS GLOBAL FUND, LTD, and FOUNDING PARTNERS HYBRID-VALUE FUND, L.P. (hereinafter "the Founding Partners Relief Defendants").

- 2. On May 13, 2009, this Court entered an Opinion and Order removing Blanco as Receiver and GrayRobinson as counsel to Blanco and directed that each should thereafter take only those actions necessary to maintain the status quo until a new receiver was appointed. [CP# 70, Paragraph 4].
- 3. On May 20, 2009, this Court entered an Order Appointing Replacement Receiver, naming Daniel Newman as replacement receiver over the Founding Partners Relief Defendants.
- 4. Paragraph 4 of the Order Appointing Receiver, in pertinent part, authorized Blanco to:
  - ...employ legal counsel...as the Receiver deems necessary and to fix and pay their reasonable compensation and reasonable expenses, as well as all reasonable expenses of taking possession of the assets and business of Founding Partners and the Relief Defendants, and exercising the power granted by this Order, subject to approval by this Court at the time to Receiver accounts to the Court for such expenditures and compensation;
- 5. Pursuant to paragraph 4 of the Order Appointing Receiver, Blanco retained GrayRobinson to provide legal services to her as receiver. GrayRobinson provided services and incurred expenses to investigate the affairs of the Receivership Entities, preserve the Receivership Assets and attempted to locate and recover additional assets during the period that Blanco served as receiver. These services were provided for the benefit of aggrieved investors, creditors, and other interested parties of the Founding Partners Relief Defendants.
- 6. Pursuant to the proposal provided to the Securities and Exchange Commission for purposes of Blanco's appointment as Receiver, Blanco agreed to cap all fees for Receiver at \$325 per hour. This rate was set forth in the Commission's Emergency Motion for Appointment of Receiver and Memorandum of Law (hereinafter "Motion for Appointment of Receiver"),

[CP# 30]. In addition, Blanco did not bill for any time for services incurred in connection with the potential conflict of interest issue raised in this case. Furthermore, Blanco has agreed to reduce her request for fees by twenty percent (20%) for the sole reason that she believes such reduction will be in the best interest of the estate. At the request of the Securities and Exchange Commission, Blanco has further agreed to a hold-back of ten percent (10%) of the amount in fees requested herein until additional funds become available.

- Blanco's fees for professional services rendered and costs incurred through July 31, 2009 amounted to \$75,010.00 in fees and \$6,472.53 in costs. However, after agreeing to reduce her fee request by twenty percent (20%), Blanco seeks an award in the amount of \$60,008.00 (i.e., 20% reduction of \$75,010.00) in fees and \$6,472.53 in costs, for a total of \$66,480.53. The request is consistent: (i) with the accommodation made to the Receiver of the hourly rate caps consistent with the Motion for Appointment of Receiver; (ii) with not billing for services rendered in connection with the potential conflict of interest issue raised in the case; and (iii) with the twenty percent (20%) reduction of the fees incurred.
- 8. The activities of Blanco for the services covered by this Motion are billed in accordance with the Billing Instructions provided by the Commission and are coded in accordance with the billing codes required therein. A copy of the time detail for the time spent by Blanco as the former Receiver in this matter is attached hereto as Exhibit "A." At the early stage of the receivership case during Blanco's term as receiver, the work of Blanco was primarily focused on locating and taking control of the receivership assets, preserving and cataloging the records of the Founding Partners Relief Defendants, meeting with aggrieved investors, addressing legal issues presented by the Sun Capital Relief Defendants. A summary of the time

spent by Blanco in each of the specific Activity Categories required under the Billing Instructions is as follows:

- 9. The detail of expenses incurred by Blanco is attached hereto as Exhibit "B."
- Neither the present receiver of this case, Daniel Newman, nor the Securities and 10. Exchange Commission have objections to the relief sought herein.

#### MEMORANDUM OF LAW

It is well settled that this Court has the power to appoint a receiver and award the receiver and those appointed by her reimbursement of professional fees and expenses. Securities and Exchange Commission v. Mobley, No. 00-CV-1316, 1317RCC, 2000 WL 1702024 (S.D.N.Y. Nov. 13, 200) (court awarded reasonable fees for the receiver and his professionals). The determination of fees to be awarded is largely within the discretion of the trial court. See Monaghan v. Hill, 140 F. 2d. 31, 34 (9th Cir. 1944). In determining reasonable compensation by a Receiver's professionals, the Court should consider the circumstances surrounding the receivership. Elliot, 953 F. 2d 1560, 1577 (11<sup>th</sup> Cir. 1992).

Here, because of the nature of this case, it was necessary for the receiver to employ attorneys familiar with financial frauds, federal receivership, securities laws, insolvency and healthcare issues. As discussed above, Blanco discounted her normal and customary rate as an accommodation to the receivership and to conserve receivership assets. The rate charged by the Blanco is at or below those charged by the attorneys and paralegals of comparable skill from other law firms in the Middle and Southern Districts of Florida. This is the first and final request for an award of compensation for services rendered by former Receiver and for un-reimbursed out-of-pocket costs although she has worked diligently on this matter and continues to do so.

This case was time-intensive for the receiver and her professionals because of the need to resolve many issues rapidly and efficiently immediately upon her appointment. The attached Exhibits detail the time, nature and extent of the professional services rendered by Blanco for the benefit of investors, creditors and other interested parties.

Although the SEC investigated and filed the initial pleadings in the case, the former receiver, with the assistance of GrayRobinson, assumed the primary responsibility for securing assets and records, investigating and analyzing events leading to the commencement of the proceeding, efforts to locate and gather investors' money and fielding of creditor and investor inquiries. The former receiver is sensitive to the need to conserve the assets of the receivership estate but maintains that the fees and costs expended during her term as receiver in this matter were reasonable, necessary and benefited the receivership.

#### CONCLUSION

Under the provisions of the Order Appointing Receiver, Blanco was authorized to apply to the Court for authority to pay fees and costs incurred in carrying out her duties and obligations as receiver. In exercising her duties, Blanco determined that the services rendered and the attendant fees and costs were reasonable, necessary, advisable and in the best interest of the receivership estate.

WHEREFORE, for the foregoing reasons, Leyza F. Blanco, former receiver in this matter, requests that this first and final application for fees and expenses of the former receiver be approved and that the Court direct that payment be made from the receivership assets in the amount of in the amount of \$60,008.00 (i.e., 20% reduction of \$75,010.00) in fees, of which ten percent (10%) will be held back until additional funds become available, and \$6,472.53 in costs, for a total of \$66,480.53, and any further relief the Court deems just and proper.
